Subject: - Contract for Lifting of waste paper category "B" from Department of Publication-regarding.

Sir,

I write to inform you that the contract for lifting of waste paper category "B" was awarded to you vide this office letter No. 111/Waste Paper/2013-2014/Gen. dated 23/06/2014. As per the contract, the work of lifting of waste paper was to be completed upto 28th February, 2015. After completing the requisite formalities and depositing the security money work order for lifting of waste paper of category "B" was issued to your firm vide this department's letter of even no dated 01/09/2014 requesting you to start the work of lifting of waste paper at the earliest. But inspite of our written and telephonic conversation neither any action in this regard was taken by you nor any response was received by this Department.

2. Subsequently you were requested vide this department's letter dated 17/10/2014 to start the process of lifting the waste paper immediately so that the space may be utilized for other Government Publications but no action had been taken by you. After that a reminder dated 29/10/2014 was issued requesting you to start the work of lifting of waste paper by 7/11/2014 positively failing which your security deposit will be forfeited and contract will be cancelled and no further communication will be communicated from this Department in this regard but failed to start the work.

3. Subsequently we had issued final notice to you vide this department letter of even no. dated 04/02/2015 stating that "tender agreement is valid up to February, 2015 which is going to be expired very shortly", and requested you to start the work of lifting of waste paper of Category "B" so that the process of tender may be completed within the time mentioned in the Agreement failing which your security deposit will be forfeited and agreement will also stand cancelled and no further communication will be made from this Department or entertained in this regard and your company will also be placed on black list for any future government contracts. But no action in this regard had been taken by you and as such you completely failed to fulfil the terms and conditions of the contract. It is further stated that the period of contract awarded to you has already expired on 28th February, 2015.

4. In view of above, the contract awarded to you by this Department for lifting of waste paper category "B" stands cancelled and your security deposit of \gtrless 22,000/- is forfeited. Your firm is also blacklisted and debarred for any future Government Contracts of this Department for the period of one year for non-fulfilment and violation of the term and conditions of the contract.
