## CIRCULAR

Subject: - Submission of Annual Immovable Property Return.

As per the Government of India's instruction and as per CCS (Conduct Rule), 1964 Annual Immovable Property Return will be filed every year as on 31st December by all group-A and group-B officers, Group-B (Non-Gazetted) officers and the officials in the pay grade of Rs. 4200/- or above in the prescribed form giving full particulars regarding the immovable property inherited by him or owned or acquired by him on lease or mortgage either in his own name or in the name of any member of his family or in the name of any other person. All the officials are required to submit Annual Immovable Property Return latest by 31st January 2015 in the prescribed Proforma enclosed herewith.

In case of violation of these instructions coming to notice of this department, a serious view will be taken against such officials and action will be initiated as per rules.

Rules. 1964), on the first appointment to the service and thereafter at the interval of every twelve months, giving particulars of all immovable property owned, acquired or inherited by him or held by him on lease or mortgage, either in his own name or in the name of any members of his family or in the name of any other person.
