



Sub: Furnishing of information under RTI Act – reg.
Sir,

In accordance with provisions of RTI Act, I request you to supply the following information and certified copies of documents within the stipulated time.

1. As per the orders of PSP Division Dy.No.62/US (PSP)/2015 dated 14.5.2015, the post of **Supervising Officer** in Department of Publication, New Delhi has been re-designated as "Superintendent/Supervisor". Kindly intimate:
 - a) The date from which the re-designation of **Superintendent/Supervisor** takes effect; and
 - b) The orders under which retrospective seniority was extended to the re-designated post of **Superintendent/Supervisor** in Department of Publication, New Delhi from the date of appointment in the post of Supervising Officer may be furnished along with the certified copy of the relevant DOPT orders.
2. Intimate the total no. of officers available in the designation of **Supervisors** or **Superintendent** or in the combined re-designated nomenclature of **Superintendent/Supervisor** in Department of Publication, New Delhi **as on 28-04-2015** and **as on 13-05-2015** and furnish their name and their date of appointment in the respective cadre.
3. Intimate the compliance of DOPT O.M.No.20020/4/2010-Estt(D) dated 13.9.2012 while finalising the inter-se-seniority which existed **as on 29.08.2008** after merger of posts/scales in feeder grade(i.e. **Supervising Officer and Head Clerk**) and after re-designation of Head Clerk Posts as Supervising Officer in Department of Publication, New Delhi consequent on implementation of 6th CPC.
4. During the period between **01.01.2000** to **13.05.2015**, how many **Supervising Officers** from Department of Publication, New Delhi has been appointed as Assistant Manager (Admn)/Assistant Controller (Publication) and furnish their name. Intimate the appointing and controlling authority for the post of Assistant Manager(Admn)/Assistant Controller(Publication)
5. A copy of approval received from the Appropriate Authority for re-designation of **Supervising Officer** as **Superintendent/Supervisor** may be supplied and the date of receipt of the said approval received by the Department of Publication may also be informed.
6. Supply the certified copy of the Recruitment Rule for the erstwhile abolished post of **Superintendent** in Department of Publication, New Delhi along with Gazette Notification GSR No. & Date of Publication etc.
7. Inform the date of creation/sanction of **Supervising Officer Post** in Department of Publication, New Delhi and number of posts created at that time. Arrange to supply the certified copy of sanction order for creation of **Supervising Officer** in Department of Publication, New Delhi issued by the Competent Authority.



9. Arrange to supply the certified copy of Recruitment Rule for the erstwhile post of **Head Clerk** in Department of Publication, New Delhi.
10. Intimate the date from which erstwhile Head Clerks have been re-designated as **Supervising Officer** and supply the certified copy of Office Order issued by the Department Of Publication in this regard. Also intimate how many Head Clerks have been re-designated as **Supervising Officer** and their name and from which date. A copy of Ministry or DOPT order under which the designation of Head Clerk has been re-designated may be supplied.
11. Arrange to supply the copy of letter with detailed proposal submitted by the Department of Publication, New Delhi to the appropriate higher authority for consideration of re-designation of erstwhile Head Clerks as **Supervising Officers**.
12. As per the Seniority List as on 1.4.2015 circulated by Department of Publication vide OM No. Seniority/B&C/Estt/15 dated 28.4.2015, there are **22 Supervising Officers** are on roll in Department of Publication, New Delhi. In this regard, intimate the date from which all the **Supervising Officers** have been re-designated as "**Superintendent/Supervisor**", the date of receipt of Competent Authority's Order, and followed by office order issued by Department of Publication, New Delhi and copy of the said office order may be supplied.
13. Intimate the transfer liability of **Supervising Officers** in Department of Publication, New Delhi.
14. Intimate how many officers of **Supervising Officer** in Department of Publication, New Delhi has been transferred out from Department of Publication, New Delhi in the past 15 years.






